## ORDER

WHEREAS, recognition was granted to the institution, namely, DELHI PUBLIC ACADEMY, PLOT NO-B-5, STREET NO B-5, TEHSIL/ CITY - GWALIOR, P.O - DEEN DAYAL NAGAR, GWALIOR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course vide order dated 18.12.2006 & 12.02.2014.

- 2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 14.01.2015 and the reply was received on 16-01-2015.
- 3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.
- 4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. AND, WHEREAS, a Show cause notice was issued to the institution on 01.09.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
  - 1) Staff Profile for the session 2015-16 duly approved by the affiliating body,
  - 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.
- 6. AND WHEREAS, the institution reply was received on 03.10.2016. The matter was placed in 296th Meeting of WRC held on August 28 - 29, 2018 and the Committee decided that "... Show Cause Notice was issued to the institution on 01.09.2016 and reply received on 03.10.2016.

Since, the institution has submitted a staff profile of 1+7, the intake is reduced from two units to one unit."

- 7. AND, WHEREAS, the reduced intake order was issued to the institution on 06.09.2018. The institution filed appeal on 01.03.2019 and regulatory file sent to NCTE, Hqr. on 08.03.2019.
- 8. AND WHEREAS, the appeal order dated 14.05.2019 remand back the case to WRC for necessary action. The reply was received from the institution on 27.05.2019 accordingly direction of the appeal order within 15 days.
- 9. AND WHEREAS, the matter was placed in 309th Meeting held on July 23rd 26th, 2019 of WRC and the Committee decided that "... The appellate authority remanded back the case to WRC vide order dated 14/05/2019.

The committee considered the observations of appellate authority and the reply submitted by the institution vide letter dated 27/05/2019 and observed that:

• The institution has submitted staff profile of 1+16 including librarian which is sufficient for two

Hence, the committee decided to restore the recognition of one additional unit (50 students) of B.Ed. programme (total 50+50 = 100 students).
